For taxes payable in 2003, the fund balance limitation under Minnesota Statutes, section 124D.20, subdivision 11, paragraph (a), is not effective for any school district that is in statutory operating debt under Minnesota Statutes, section 123B.81, and, notwithstanding Minnesota Statutes, section 124D.20, subdivision 11, paragraph (b), the levy reduction is not effective for any school district that is in statutory operating debt."

Page 8, line 28, delete "85,600,000" and insert "108,558,000"

"[LOAN FOR CASH FLOW PURPOSES.] Of this appropriation, \$21,000,000 is to establish a loan program for counties that experience cash flow problems as a result of the shift of payment dates authorized in this subdivision. A county may apply for a loan under this paragraph. The

commissioner may approve a loan to a county that demonstrates need under criteria established by the commissioner. The commissioner is exempt from the rulemaking requirements of chapter 14 for the purposes of this paragraph. A county that receives a loan under this paragraph must repay the loan by July 31, 2003. By August 15, 2003, the commissioner of human services shall transfer \$21,000,000 to the commissioner of finance for cancellation to the general fund.

[PAYMENT SHIFT.] Of this appropriation, a reduction of \$13,994,000 is due to the shift of payment dates authorized in this subdivision."

"Sec. 2. TRADE AND ECONOMIC DEVELOPMENT (713,000)

This is a onetime appropriation reduction.

Of this amount, \$35,000 is from the appropriation made in Laws 2001, First Special Session chapter 4, article 1, section 2, subdivision 2, for a onetime grant for a pilot project incubated by Blue Earth county named the Rural Advanced Business Facilitation Program.

## Sec. 3. ECONOMIC SECURITY

(65,000)

This includes a onetime appropriation reduction of \$189,000 and an additional appropriation of \$124,000 for state services for the blind."

This is a onetime appropriation reduction, of which \$64,000 is from appropriations for folk arts."
