**S.F. No. 1835:** A bill for an act relating to insurance; amending provisions relating to health coverage for school district employees; appropriating money; amending Minnesota Statutes 2012, sections 43A.316, by adding a subdivision; 123A.21, subdivisions 5, 6, 9; 123B.09, subdivision 12; 471.6161, subdivisions 1, 2, 3, by adding a subdivision; 471.895, subdivision 1; Minnesota Statutes 2013 Supplement, section 124D.10, subdivision 8.

Subd. 10. **Exemption.** The public employee insurance program and, where applicable, the employers participating in it are exempt from chapters 60A, 62A, 62C, 62D, 62E, and 62H, section 471.617, subdivisions 2 and 3, ~~and the bidding requirements of section 471.6161.~~"

Page 7, line 11, delete "either" and delete "or in the" and insert "but not more frequently than every 24 months"

Page 7, line 12, delete everything before the period

Page 7, line 25, delete everything before the period and insert "unless the exclusive representative of the largest employment group and the school district agree otherwise"

Page 7, after line 28, insert:

"(f) School districts are allowed to negotiate with entities referenced in subdivision 1 that submitted bids."

Page 8, after line 4, insert:

"Sec. 13. **REPORT.**

The commissioner of management and budget shall report by January 15, 2015, to the chairs and ranking minority members of the senate Finance Committee and house of representatives Ways and Means Committee on the costs for the public employees insurance program to comply with the requirements of this act."

Page 8, line 6, before "\$1,000,000" insert "(a)"

Page 8, line 8, delete everything after "43A.316"

Page 8, line 9, delete everything before the second period

Page 8, after line 9, insert:

"(b) \$50,000 is appropriated for fiscal year 2015 from the general fund to the commissioner of management and budget for costs of the report referenced in section 13."

**Senator Bonoff from the Committee on Higher Education and Workforce Development, to which was referred**

**S.F. No. 403:** A bill for an act relating to higher education; requiring the study of a state loan program to refinance student loans.

Delete everything after the enacting clause and insert:

"Section 1. **[136A.1704] STUDENT LOAN REFINANCING.**

The office may refinance student and parent loans on terms and conditions the office prescribes. The office may establish credit requirements for borrowers and determine what types of student and parent loans will be eligible for refinancing. The refinanced loan need not have been made through a loan program administered by the office."

The commissioner, in consultation with the advisory council, shall identify the music healing professions that qualify for this exemption."

Page 4, line 19, delete the comma and insert a semicolon

Page 4, delete line 20 and insert:

"(6) provide proof that the applicant is currently a board certified or registered music therapist."

Page 5, line 11, delete "For one year following enactment of this chapter," and insert "(a)"

Page 5, after line 17, insert:

"(b) This section expires July 1, 2016."

Page 5, line 26, delete "and"

Page 5, before line 27, insert:

"(4) submit proof of completion of a minimum of 100 hours of continuing education in a program approved by the Certification Board of Music Therapists or its successor organization; and"

Page 5, line 27, delete "(4)" and insert "(5)"

Page 7, line 23, before "services" insert "music therapy"

Page 9, line 7, delete "these"

Page 9, line 23, delete "the day following final enactment" and insert "July 1, 2014"

And when so amended the bill do pass and be re-referred to the Committee on State and Local Government. Amendments adopted. Report adopted.

**Senator Latz from the Committee on Judiciary, to which was referred**

**S.F. No. 1725:** A bill for an act relating to public safety; providing for accreditation of forensic laboratories; proposing coding for new law in Minnesota Statutes, chapter 299C.

If the standard described in paragraph (a), (b), or (c), under which the laboratory is accredited applies to the new discipline, the laboratory must become accredited in the new discipline under the appropriate standard within one year of when it first begins conducting forensic analysis in the new discipline. If the standard described in paragraph (a), (b), or (c), under which the laboratory is accredited does not apply to the new discipline, the laboratory must become accredited in the new discipline under the appropriate standard within three years of when it first begins conducting forensic analysis in the new discipline. A laboratory seeking accreditation in a new discipline under this paragraph must follow the standards necessary for accreditation during the period before accreditation."

"(f) Notwithstanding paragraphs (d) and (e), upon the written request of a laboratory that contains the specific reasons for the request, the commissioner of public safety may extend by one year the three-year and one-year periods described in paragraphs (d) and (e) by which a laboratory must become initially accredited or accredited in a new discipline. Each deadline may be extended only once."

Page 3, line 4, after the period, insert "A forensic laboratory seeking accreditation in a new discipline must forward to the commissioner every six months an affirmation that the laboratory is in compliance with paragraph (e)."
