**REPORTS OF COMMITTEES**

Senator Gazelka moved that the Committee Reports at the Desk be now adopted, with the exception of the report pertaining to the appointment. The motion prevailed.

**Senator Newman from the Committee on Transportation Finance and Policy, to which was referred**

**S.F. No. 1538:** A bill for an act relating to transportation; amending the information that must be exchanged between drivers after a collision; amending Minnesota Statutes 2018, section 169.09, subdivision 3.

Reports the same back with the recommendation that the bill do pass. Report adopted.

**Senator Newman from the Committee on Transportation Finance and Policy, to which was referred**

**S.F. No. 2224:** A bill for an act relating to motor vehicles; modifying the class of vehicles requiring a salvage certificate of title; amending Minnesota Statutes 2018, section 168A.151, subdivision 1.

Reports the same back with the recommendation that the bill do pass and be re-referred to the Committee on Finance. Report adopted.

**Senator Newman from the Committee on Transportation Finance and Policy, to which was referred**

**S.F. No. 2935:** A bill for an act relating to transportation; requiring road authorities to notify the owner of a private road prior to conducting work on the road; amending Minnesota Statutes 2018, section 160.05, subdivision 1.

Reports the same back with the recommendation that the bill do pass and be re-referred to the Committee on Local Government. Report adopted.

**Senator Limmer from the Committee on Judiciary and Public Safety Finance and Policy, to which was referred**

**S.F. No. 1256:** A bill for an act relating to public safety; requiring law enforcement policies on best practices for eyewitness identifications; proposing coding for new law in Minnesota Statutes, chapter 624.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

"Section 1. **[626.8433] EYEWITNESS IDENTIFICATION POLICIES REQUIRED.**

Subdivision 1. **Statewide model policy required.** By November 1, 2020, the board, in consultation with stakeholders, shall develop a model policy that articulates best practices in eyewitness identification and promotes uniform practices statewide. The board shall distribute this model policy to all chief law enforcement officers. At a minimum, the policy must require that:

(1) a person administering a live or photographic lineup be unaware of the suspect's identity, or if that is not practical, the administrator use a photographic lineup that prevents the administrator from seeing which member of the photographic lineup is being viewed by the eyewitness at a given time;

(2) before the procedure, the eyewitness be instructed that the perpetrator may or may not be in the lineup;

(3) nonsuspect "fillers" used in the lineup be substantially similar to the eyewitness' description of the perpetrator; and

(4) immediately after an identification is made, the eyewitness provide a statement in the eyewitness' own words that articulates the level of the eyewitness' confidence in the identification.

Subd. 2. **Agency policies required.** By February 1, 2021, the chief law enforcement officers of every state and local law enforcement agency shall adopt and implement a written policy on eyewitness identification practices that is identical to or substantially similar to the model policy developed under subdivision 1.

Subd. 3. **Admissibility of evidence not impacted.** Nothing in this section is intended to preclude the admissibility of any relevant evidence or to affect the standards governing the admissibility of evidence under the United States Constitution or Minnesota Constitution."

Amend the title numbers accordingly

**S.F. No. 2978:** A bill for an act relating to courts; modifying criteria for publishing court of appeals opinions; amending Minnesota Statutes 2018, section 480A.08, subdivision 3.

Reports the same back with the recommendation that the bill do pass. Report adopted.

**Senator Limmer from the Committee on Judiciary and Public Safety Finance and Policy, to which was referred**

**S.F. No. 1950:** A bill for an act relating to public safety; authorizing local units of government to conduct criminal background checks under certain circumstances; proposing coding for new law in Minnesota Statutes, chapter 299C.

Reports the same back with the recommendation that the bill be amended as follows:

Page 1, line 14, delete "a cabaret" and insert "an adult entertainment establishment as defined in section 617.242, subdivision 1, clause (1)"

**Senator Limmer from the Committee on Judiciary and Public Safety Finance and Policy, to which was referred**

**S.F. No. 1621:** A bill for an act relating to public safety; regulating the manufacture, sale, and use of fireworks; dedicating a portion of revenues from the sale of certain fireworks for public safety purposes; amending Minnesota Statutes 2018, sections 297A.94; 624.20, subdivision 1.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

"Section 1. Minnesota Statutes 2018, section 297A.94, is amended to read:

**297A.94 DEPOSIT OF REVENUES.**

(a) Except as provided in this section, the commissioner shall deposit the revenues, including interest and penalties, derived from the taxes imposed by this chapter in the state treasury and credit them to the general fund.

(b) The commissioner shall deposit taxes in the Minnesota agricultural and economic account in the special revenue fund if:

(1) the taxes are derived from sales and use of property and services purchased for the construction and operation of an agricultural resource project; and

(2) the purchase was made on or after the date on which a conditional commitment was made for a loan guaranty for the project under section 41A.04, subdivision 3.

The commissioner of management and budget shall certify to the commissioner the date on which the project received the conditional commitment. The amount deposited in the loan guaranty account must be reduced by any refunds and by the costs incurred by the Department of Revenue to administer and enforce the assessment and collection of the taxes.

(c) The commissioner shall deposit the revenues, including interest and penalties, derived from the taxes imposed on sales and purchases included in section 297A.61, subdivision 3, paragraph (g), clauses (1) and (4), in the state treasury, and credit them as follows:

(1) first to the general obligation special tax bond debt service account in each fiscal year the amount required by section 16A.661, subdivision 3, paragraph (b); and

(2) after the requirements of clause (1) have been met, the balance to the general fund.

(d) Beginning with sales taxes remitted after July 1, 2017, the commissioner shall deposit in the state treasury the revenues collected under section 297A.64, subdivision 1, including interest and penalties and minus refunds, and credit them to the highway user tax distribution fund.

(e) The commissioner shall deposit the revenues, including interest and penalties, collected under section 297A.64, subdivision 5, in the state treasury and credit them to the general fund. By July 15 of each year the commissioner shall transfer to the highway user tax distribution fund an amount equal to the excess fees collected under section 297A.64, subdivision 5, for the previous calendar year.

(f) Beginning with sales taxes remitted after July 1, 2017, in conjunction with the deposit of revenues under paragraph (d), the commissioner shall deposit into the state treasury and credit to the highway user tax distribution fund an amount equal to the estimated revenues derived from the tax rate imposed under section 297A.62, subdivision 1, on the lease or rental for not more than 28 days of rental motor vehicles subject to section 297A.64. The commissioner shall estimate the amount of sales tax revenue deposited under this paragraph based on the amount of revenue deposited under paragraph (d).

(g) Starting after July 1, 2017, the commissioner shall deposit an amount of the remittances monthly into the state treasury and credit them to the highway user tax distribution fund as a portion of the estimated amount of taxes collected from the sale and purchase of motor vehicle repair parts in that month. For the remittances between July 1, 2017, and June 30, 2019, the monthly deposit amount is \$2,628,000. For remittances in each subsequent fiscal year, the monthly deposit amount is \$12,137,000. For purposes of this paragraph, "motor vehicle" has the meaning given in section 297B.01, subdivision 11, and "motor vehicle repair and replacement parts" includes (i) all parts, tires, accessories, and equipment incorporated into or affixed to the motor vehicle as part of the motor vehicle maintenance and repair, and (ii) paint, oil, and other fluids that remain on or in the motor vehicle as part of the motor vehicle maintenance or repair. For purposes of this paragraph,

"tire" means any tire of the type used on highway vehicles, if wholly or partially made of rubber and if marked according to federal regulations for highway use.

(h) 72.43 percent of the revenues, including interest and penalties, transmitted to the commissioner under section 297A.65, must be deposited by the commissioner in the state treasury as follows:

(1) 50 percent of the receipts must be deposited in the heritage enhancement account in the game and fish fund, and may be spent only on activities that improve, enhance, or protect fish and wildlife resources, including conservation, restoration, and enhancement of land, water, and other natural resources of the state;

(2) 22.5 percent of the receipts must be deposited in the natural resources fund, and may be spent only for state parks and trails;

(3) 22.5 percent of the receipts must be deposited in the natural resources fund, and may be spent only on metropolitan park and trail grants;

(4) three percent of the receipts must be deposited in the natural resources fund, and may be spent only on local trail grants; and

(5) two percent of the receipts must be deposited in the natural resources fund, and may be spent only for the Minnesota Zoological Garden, the Como Park Zoo and Conservatory, and the Duluth Zoo.

(i) The revenue dedicated under paragraph (h) may not be used as a substitute for traditional sources of funding for the purposes specified, but the dedicated revenue shall supplement traditional sources of funding for those purposes. Land acquired with money deposited in the game and fish fund under paragraph (h) must be open to public hunting and fishing during the open season, except that in aquatic management areas or on lands where angling easements have been acquired, fishing may be prohibited during certain times of the year and hunting may be prohibited. At least 87 percent of the money deposited in the game and fish fund for improvement, enhancement, or protection of fish and wildlife resources under paragraph (h) must be allocated for field operations.

(j) The commissioner must deposit the revenues, including interest and penalties minus any refunds, derived from the sale of items regulated under section 624.20, subdivision 1, that may be sold to persons 18 years old or older and that are not prohibited from use by the general public under section 624.21, in the state treasury and credit:

(1) 25 percent to the volunteer fire assistance grant account established under section 88.068;

(2) 25 percent to the fire safety account established under section 297I.06, subdivision 3; and

(3) the remainder to the general fund.

For purposes of this paragraph, the percentage of total sales and use tax revenue derived from the sale of items regulated under section 624.20, subdivision 1, that are allowed to be sold to persons 18 years old or older and are not prohibited from use by the general public under section 624.21, is a set percentage of the total sales and use tax revenues collected in the state, with the percentage determined under Laws 2017, First Special Session chapter 1, article 3, section 39.

(k) Beginning with sales taxes remitted after June 30, 2020, the commissioner shall deposit the revenues, including penalties and interest and less refunds, derived from the taxes imposed on the sale of aerial and audible devices, in the state treasury and credit: (1) 25 percent to the volunteer fire assistance grant account in the special revenue fund for grants under section 88.067; (2) 25 percent to the fire safety account established under section 297I.06, subdivision 3; and (3) the remainder to the general fund. For purposes of this section, "aerial and audible devices" has the meaning given in section 624.20, subdivision 1, paragraph (a). The commissioner shall estimate the percentage of total sales tax revenue attributable to the sale of aerial and audible devices to calculate the amount of annual revenue that should be paid to the account under this paragraph in fiscal year 2021 and each subsequent fiscal year.

~~(k) (l)~~ (l) The revenues deposited under paragraphs (a) to ~~(j)~~ (k) do not include the revenues, including interest and penalties, generated by the sales tax imposed under section 297A.62, subdivision 1a, which must be deposited as provided under the Minnesota Constitution, article XI, section 15.

**EFFECTIVE DATE.** This section is effective for sales and purchases made after June 30, 2020.

Sec. 2. Minnesota Statutes 2018, section 624.20, subdivision 1, is amended to read:

Subdivision 1. **Regulation.** (a) ~~As used in sections 624.20 to 624.25, the term "fireworks" means any substance or combination of substances or article prepared for the purpose of producing a visible or an audible effect by combustion, explosion, deflagration, or detonation, and includes blank cartridges, toy cannons, and toy canes in which explosives are used, the type of balloons which require fire underneath to propel them, firecrackers, torpedoes, skyrocketes, Roman candles, daygo bombs, sparklers other than those specified in paragraph (c), or other fireworks of like construction, and any fireworks containing any explosive or inflammable compound, or any tablets or other device containing any explosive substance and commonly used as fireworks.;~~

~~(b) The term "fireworks" shall not include toy pistols, toy guns, in which paper caps containing 25/100 grains or less of explosive compound are used and toy pistol caps which contain less than 20/100 grains of explosive mixture.~~

~~(c) The term also does not include wire or wood sparklers of not more than 100 grams of mixture per item, other sparkling items which are nonexplosive and nonaerial and contain 75 grams or less of chemical mixture per tube or a total of 500 grams or less for multiple tubes, snakes and glow worms, smoke devices, or trick noisemakers which include paper streamers, party poppers, string poppers, snappers, and drop pops, each consisting of not more than twenty five hundredths grains of explosive mixture. The use of items listed in this paragraph is not permitted on public property. This paragraph does not authorize the purchase of items listed in it by persons younger than 18 years of age. The age of a purchaser of items listed in this paragraph must be verified by photographic identification.~~

(1) "aerial and audible devices" means fireworks in a finished state, suitable for use by the public, listed in APA 87-1, sections 3.1.2, 3.1.3, and 3.5, and containing 75 grams or less of chemical mixture per tube for a total of 500 grams or less for multiple tubes in a device;

(2) "APA 87-1" means the American Pyrotechnics Association Standard 87-1 from the Standard for Construction and Approval for Transportation of Fireworks, Novelties, and Theatrical Pyrotechnics, 2001 Edition;

(3) "display fireworks" means firework devices in a finished state, exclusive of mere ornamentation, primarily intended for commercial displays that are designed to produce visible effects, audible effects, or both, by combustion, deflagration, or detonation. The term includes, but is not limited to, salutes containing more than 130 milligrams of explosive composition, aerial shells containing more than 40 grams of chemical composition exclusive of light charge, and other exhibition display items that exceed the limits contained in APA 87-1 for aerial and audible devices;

(4) "fireworks" means any device, other than sparkling devices, novelties, aerial and audible devices, or theatrical pyrotechnic articles that are intended to produce visible effects, audible effects, or both, by combustion, deflagration, or detonation. The term includes display fireworks;

(5) "novelties" means devices containing small amounts of pyrotechnic composition that are listed in APA 87-1, sections 3.2, 3.3, and 3.4. The term includes deregulated sparklers, snakes and glow worms, smoke devices, and trick noisemakers, including paper streamers, party poppers, string poppers, snappers, drop pops, each consisting of not more than 25/100 grains of explosive mixture; toy pistols, toy guns, in which paper caps containing 25/100 grains or less of explosive compound are used; and toy pistol caps that contain less than 20/100 grains of explosive mixture; and

(6) "sparkling devices" means ground-based or handheld devices that produce a shower of sparks that are listed in APA 87-1, sections 3.1.1 and 3.5. The term includes fountains, torches, wheels, ground spinners, flutter sparklers, toy smoke devices, and sparklers.

(b) Nothing in sections 624.20 to 624.25 authorizes the possession or use of sparkling devices, novelties, or aerial and audible devices on public property, or the purchase of these items by persons younger than 18 years of age. A person selling sparkling devices, novelties, or aerial and audible devices shall verify the age of a purchaser by photographic identification. Nothing in sections 624.20 to 624.25 authorizes the use of aerial and audible devices other than during the period from 12:00 p.m. to 10:00 p.m., or one and one-half hours after sunset, whichever is later.

(c) A retail seller of sparkling devices, novelties, or aerial and audible devices may operate out of a temporary structure for no more than 45 days in a calendar year. A retail seller operating beyond 45 days in a calendar year must do so from a permanent structure.

(d) A local unit of government may impose an annual license fee for the retail sale of ~~items authorized under paragraph (e) sparkling devices and aerial and audible devices.~~ The annual license fee of each retail seller that is in the business of selling only ~~the items authorized under paragraph (e) sparkling devices or aerial and audible devices, or both,~~ may not exceed \$350 for a single retail location, and the annual license of each other retail seller may not exceed \$100. A local unit of government may assess a fee, not to exceed \$100, to a licensee for each additional retail location that the licensee operates. A license application must be made before June 1 of each year and must require, at a minimum, the location of each retail location the licensee intends to operate. The local authority having jurisdiction shall, within 14 days after the receipt of an application for a license, either issue the license or notify the applicant of the denial of the license. A licensee must display the license issued pursuant to this paragraph at each point of sale operated by the licensee. A license

issued under this paragraph expires May 31 of the year following the year of issuance. A local unit of government may not:

(1) impose any fee or charge, other than the fee authorized by this paragraph, on the wholesale or retail sale of items authorized under paragraph (e) sparkling devices and aerial and audible devices;

(2) except to comply with paragraph (c), prohibit or restrict the sale or display of items for sparkling devices, novelties, or aerial and audible devices from any permanent or temporary retail sale authorized under paragraph (e) structure that ~~comply~~ complies with National Fire Protection Association Standard 1124 (2003 2006 edition); or

(3) impose on a retail seller any financial guarantee requirements, including bonding or insurance provisions, containing restrictions or conditions not imposed on the same basis on all other business licensees; or

(4) enact any ordinance, rule, or regulation that prohibits, limits, or restricts the wholesale or retail sale of novelties.

(e) This section does not preempt a town or home rule charter or statutory city from enacting and enforcing ordinances under the city charter or chapter 365, 368, 412, or 462, that regulate the conditions of sale or use for sparkling devices, aerial and audible devices, and display fireworks.

(f) For the purposes of regulating the conditions of sale or use for aerial and audible devices, display fireworks, sparkling devices, and novelties, a county has the same authority and power granted to a statutory city by paragraph (e) and chapter 412. If a home rule charter or statutory city or town has enacted an ordinance, rule, or regulation under paragraph (e), that ordinance, rule, or regulation prevails within the city or town.

(g) Nothing in sections 624.20 to 624.25 authorizes the sale or use of aerial and audible devices within a metropolitan county, as defined in section 473.121, subdivision 4.

**EFFECTIVE DATE.** This section is effective June 1, 2020."

**Senator Abeler from the Committee on Human Services Reform Finance and Policy, to which was referred**

**S.F. No. 3003:** A bill for an act relating to human services; providing vocational services for individuals with disabilities; requiring reports.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

**"Section 1. DIRECTION TO THE COMMISSIONERS OF HUMAN SERVICES, EDUCATION, AND EMPLOYMENT AND ECONOMIC DEVELOPMENT; PLANS TO PROMOTE EMPLOYMENT OF INDIVIDUALS WITH DISABILITIES.**

**Subdivision 1. Plan for supported employment of transition-age youth and individuals with significant support needs.** (a) The commissioners of human services, education, and employment and economic development, in consultation with local education agencies, shall develop and implement a plan to assist transition-age youth with disabilities between the ages of 14 and 24 to maximize opportunities to achieve competitive integrated employment, including by use of customized employment strategies and other individualized options, via services provided by vocational

rehabilitation services and by local education agencies and funded under Title I and Title VI, Part B of the Rehabilitation Act.

(b) The commissioners shall jointly develop a coordinated plan to expand employment options for individuals with significant disabilities, including mental illness, for whom competitive integrated employment has not traditionally occurred, for whom competitive employment has been interrupted or intermittent as a result of the individual's disability, or who selected competitive integrated employment in their most recent career counseling and referral assessment, and who have:

(1) the ability or potential to engage in a training or postsecondary program leading to employment with or without supports; or

(2) a demonstrated need for intensive ongoing support services or extended services in order to perform competitive integrated work.

Subd. 2. **Plan for expansion of competitive integrated employment.** (a) In consultation with stakeholders, including disability advocacy organizations, employment service providers, lead agencies in the seven-county metropolitan area and greater Minnesota, private businesses, individuals with disabilities, and other interested parties, the commissioners shall develop a plan to prioritize and create incentives for competitive integrated employment of individuals with disabilities at minimum wage or higher, including through the use of customized employment strategies and other individualized supports, and to reduce dependence on less integrated service models.

(b) The plan must include recommendations to:

(1) align funding to support informed decision-making and individualized employment outcomes;

(2) create incentives for competitive integrated employment services for people with disabilities;

(3) build capacity for increased demand on competitive integrated employment services and supports, including customized employment and other individualized options;

(4) ensure equitable access to competitive integrated employment and employment services for individuals with disabilities who experience unique barriers, including but not limited to:

(i) people of color and American Indians;

(ii) residents of Greater Minnesota;

(iii) individuals with disabilities and mental illness who are not eligible for Medicaid waivers;  
and

(iv) other populations as identified by the commissioner and stakeholders;

(5) create partnership initiatives and establish hiring incentives for private businesses to employ individuals with disabilities and to help address labor shortages across industry segments;

(6) educate employers about accommodations in the workplace and supports available in implementing these accommodations;

(7) support small businesses owned and actively operated by individuals with disabilities;

(8) expand microgrants to support the employment of individuals with disabilities at minimum wage or higher;

(9) provide training and technical assistance for disability service providers transitioning to support competitive integrated employment; and

(10) identify best practice standards in community integration for day services that support individuals with disabilities who do not choose paid employment.

The report must include legislative recommendations for implementing each plan. The report must also include summary data as defined in Minnesota Statutes, section 13.02, subdivision 19, including:

(1) the number of individuals with disabilities who have completed either career counseling information and referrals or MnCHOICES assessments and indicated a preference for competitive integrated employment:

(i) by age;

(ii) by county of residence;

(iii) by type of home and community-based services or vocational rehabilitation services accessed;

(2) the number of individuals with disabilities who have secured customized competitive integrated employment:

(i) by duration of employment in an integrated setting;

(ii) by the number of hours per week worked in an integrated setting;

(iii) by types of employer;

(iv) by hourly wage;

(3) range, distribution, median, and average earnings of individuals with disabilities prior to moving into competitive integrated employment;

(4) the ability or inability of service providers to meet individuals' demand for competitive integrated employment supports statewide, including through the use of customized employment;

(5) data from states that have phased out the use of 14c certificates and a subminimum wage, showing the number of adults with disabilities employed, average hours worked, and average hourly wages earned before and after subminimum wage was eliminated; and

(6) other summary data as identified and agreed upon by the commissioners."

Grants are limited to 75 percent of the farmer's documented cost to purchase, ship, and install grain silo air quality monitoring equipment or \$500, whichever is less.

Subd. 3. **Promotion; administration.** The commissioner may spend up to five percent of total program dollars each fiscal year to promote and administer the program to Minnesota farmers.

Subd. 4. **Nonstate sources; appropriation.** The commissioner must accept contributions from nonstate sources, including but not limited to nonprofits, foundations, and corporations to supplement state appropriations for this program. Contributions received under this subdivision are appropriated to the commissioner for purposes of this section.

Sec. 2. **APPROPRIATION.**

(a) \$..... is appropriated from the general fund in fiscal year 2021 to the commissioner of agriculture for the grain storage facility safety grant program under Minnesota Statutes, section 17.121.

(b) \$25,000 in fiscal year 2021 is appropriated from the general fund to the commissioner of agriculture for a grant to the Board of Regents of the University of Minnesota for University of Minnesota Extension to create and present curriculum regarding grain storage facility safety. The

University of Minnesota Extension is encouraged to collaborate with stakeholders, including 4-H, Future Farmers of America, and agriculture education programs through the schools to ensure these resources are available to current and future farmers.

(c) \$25,000 in fiscal year 2021 is appropriated to the commissioner of agriculture for grants to the Board of Regents of the University of Minnesota or the Board of Trustees for the Minnesota State Colleges and Universities to design digital applications that allow a user to remotely power off a grain storage facility via cell phone or electronic device. By January 15, 2021, the commissioner shall report on the grants issued under this appropriation to the members of the legislative committees with jurisdiction over agriculture finance and higher education finance."

Delete the title and insert:

"A bill for an act relating to agriculture; establishing a grain storage facility grant program; appropriating money for grain storage facility safety grants and curriculum development; proposing coding for new law in Minnesota Statutes, chapter 17."

"Section 1. Minnesota Statutes 2018, section 256C.02, is amended to read:

**256C.02 PUBLIC ACCOMMODATIONS.**

People who are blind or people with a visual or physical disability have the same right as the able-bodied to the full and free use of the streets, highways, sidewalks, walkways, public buildings, public facilities, and other public places; and are entitled to full and equal accommodations, advantages, facilities, and privileges of all common carriers, airplanes, motor vehicles, railroad trains, motor buses, boats, or any other public conveyances or modes of transportation, hotels, lodging places, places of public accommodation, amusement, or resort, and other places to which the general public is invited, subject only to the conditions and limitations established by law and applicable alike to all persons.

Every person who is totally or partially blind, or person who is deaf, or person with a physical disability, or any person training a dog to be a service dog shall have the right to be accompanied by a service dog in any of the places listed in section 363A.19. The person shall be liable for any damage done to the premises or facilities by such dog. ~~The service dog must be capable of being properly identified as from a recognized school for seeing eye, hearing ear, service, or guide dogs.~~

Sec. 2. Minnesota Statutes 2018, section 363A.09, subdivision 5, is amended to read:

Subd. 5. **Real property full and equal access.** It is an unfair discriminatory practice for a person to deny full and equal access to real property provided for in sections 363A.08 to 363A.19, and 363A.28, subdivision 10, to a person who ~~is totally or partially blind, deaf, or has a physical or sensory~~ has a disability and who uses a service animal, ~~if the service animal can be properly identified as being from a recognized program which trains service animals to aid persons who are totally or partially blind or deaf or have physical or sensory disabilities.~~ The person may not be required to pay extra compensation for the service animal but is liable for damage done to the premises by the service animal.

Sec. 3. **[504B.113] SERVICE AND SUPPORT ANIMAL DOCUMENTATION.**

Subdivision 1. Definitions. (a) For purposes of this section, the following terms have the meanings given.

(b) "Service animal" has the meaning given in Code of Federal Regulations, title 28, section 36.104, as amended.

(c) "Support animal" means an animal that: (1) provides emotional support that alleviates one or more identified symptoms or effects of a person's disability; and (2) does not need to be trained to perform a specific disability-related task.

(d) "Tenant" means a current tenant or a prospective tenant.

(e) "Licensed professional" means a provider of care who is:

(1) a person licensed by the Board of Medical Practice under chapter 147;

(2) a physician assistant licensed under chapter 147A;

(3) a nurse, as defined in section 148.171, subdivision 9, licensed under chapter 148;

(4) a psychologist licensed under chapter 148;

(5) a mental health professional licensed under chapter 148B;

(6) a social worker licensed under chapter 148E;

(7) a counselor licensed under chapter 148F; or

(8) any professional listed in clauses (1) to (7) who holds a valid license in any other state, provided the professional has an existing treatment relationship with the tenant requesting a reasonable accommodation.

A licensed professional does not include any person who operates primarily to provide certification for a service or support animal.

(f) "Reasonable accommodation" means the granting of a waiver by a landlord of a no-pets or pet-fee policy for a person with a disability consistent with the Fair Housing Act, United States Code, title 42, sections 3601 to 3619, as amended, and section 504 of the Rehabilitation Act of 1973, United States Code, title 29, section 701, as amended.

**Subd. 2. Request for documentation permitted.** (a) A landlord may require a tenant to provide supporting documentation for each service or support animal for which the tenant requests a reasonable accommodation under any provision of law. A landlord must not require supporting documentation from a tenant if the tenant's disability or disability-related need for a service or support animal is readily apparent or already known to the landlord.

(b) Upon a landlord's request, the tenant must provide supporting documentation from a licensed professional confirming the tenant's disability and the relationship between the tenant's disability and the need for a service or support animal. A landlord must not require the tenant to disclose or provide access to medical records or medical providers or provide any other information or documentation of a person's physical or mental disability.

**Subd. 3. Additional fees or deposits prohibited.** A landlord must not require a tenant with a reasonable accommodation under this section to pay an additional fee, charge, or deposit for the service or support animal. A tenant is liable to the landlord for any damage to the premises caused by the service or support animal.

**Subd. 4. Prohibited conduct.** A tenant must not, directly or indirectly through statements or conduct, knowingly:

(1) misrepresent themselves as a person with a disability that requires the use of a service or support animal; or

(2) provide fraudulent supporting documentation under this section.

**Subd. 5. Penalty.** If a tenant violates this section, the landlord may deny the tenant's rental application or request for a service or support animal. Nothing in this section shall be construed to prohibit an eviction action based on a breach of the lease."

Delete the title and insert:

"A bill for an act relating to housing; permitting a landlord to require a tenant to provide documentation supporting the tenant's need for a service or support animal; amending Minnesota Statutes 2018, sections 256C.02; 363A.09, subdivision 5; proposing coding for new law in Minnesota Statutes, chapter 504B."
